CONFIDENTIALITY OBLIGATIONS OF THE PARTIES .

Nothing in this Clause shall restrict any Party from disclosing Confidential Information for the following purposes:

- a. To the extent that such confidential information is in the public domain other than by breach of this Agreement;
- b. To the extent that any of such confidential information was previously known or already in the lawful possession of such Party, prior to disclosure by any other Party hereto

c. Neither Party shall be liable for any failure to perform its obligations under this Agreement if prevented from doing so by a cause or causes beyond its control. Without limiting the generality of the foregoing, such causes include epidemics, Acts of God, or the public enemy, fires, floods, storms, earthquakes, riots, strikes, lockouts,

d. acts of terrorism, wars or war operations, restraints of government or other cause or causes which could not with reasonable diligence be controlled or prevented by such party

TERM AND TERMINATION

- 1. The term of this Agreement shall be one year (1 year) unless terminated by either Party prior to the expiry of the said term. The Agreement can be further extended mutually by both Parties in case so agreed by both the Parties in writing.
- 2. This Agreement can be terminated by either Party by giving a notice of 30 days to the other Party.

ARBITRATION AND JURISDICTION OF COURTS

- All disputes arising out of or connection with this Agreement shall be referred to a sole Arbitrator to be nominated by mutual consent of the Parties, under the Arbitration and Conciliation Act, 1996. The place of Arbitration shall be Mumbai. The Arbitral award passed by the sole Arbitrator shall be binding on both the Parties
- 4. Subject to the Arbitration clause agreed hereinabove, the Courts at Mumbai shall have exclusive jurisdiction in relation to any matter or issue arising out of the present Agreement.
